### Fashion and Accessories Design Forecasting. Trends. Markets...

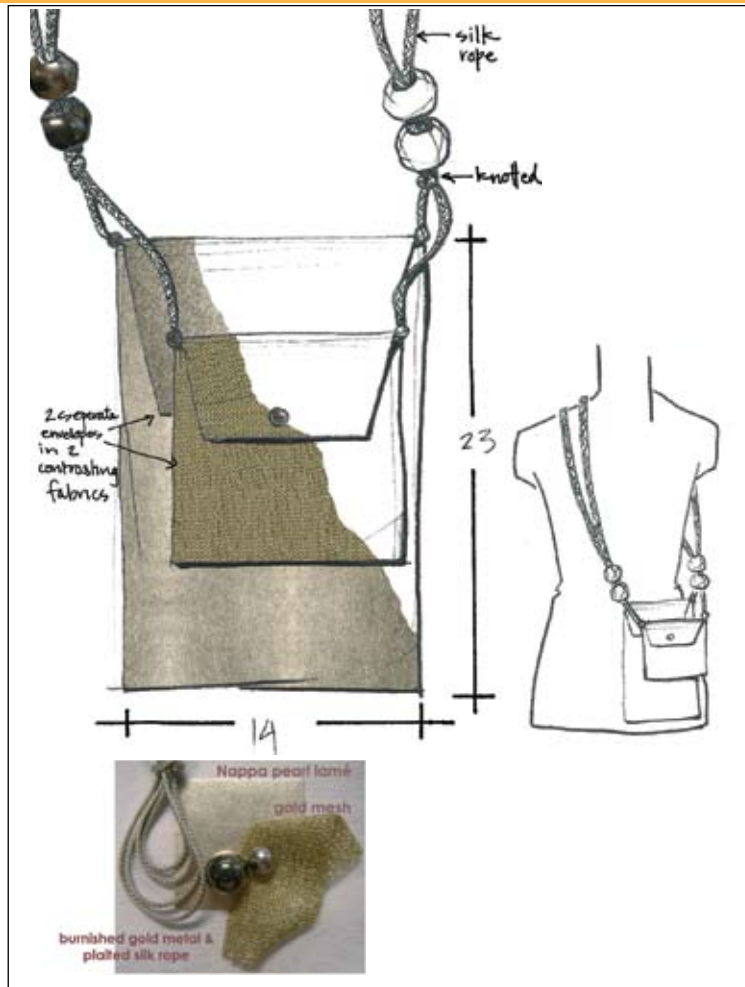
